Presiding Commissioner Ted Findley called the meeting to order at 9:00 a.m.
Commissioner Regan Nonneman made a motion to approve the minutes and agenda. Commissioner Tyler Paxson seconded. All in favor, motion carried.

Treasurer Linda Brown presented the weekly financial report, payroll and bills.

Commissioner Regan Nonneman made a motion to approve the payroll and bills. Commissioner Tyler Paxson seconded. All in favor, motion carried

EMD Gene Auten reported that there are fewer funds available for the EMG grant, so he will have to resubmit his grant application. We may or may not what we request.

Economic Developer: Discussed the old run down properties in the county and how to properly dispose of them.

Jackie Spainhower from Northwest Regional Council of Governments dropped by with a County Road Report she is working on. She had the commissioners and Jim Fletchall prioritize their needs on bridges and low water crossings in the county. She will use this information if hazard mitigation, or grant money becomes available.

County Road and Bridge Supervisor Jim Fletchall reported

- They almost have the maintenance rock applied to CR 281/Lyon Ave/old 169 south of Grant City. The commissioners advised Fletchall to have Wieland Hauling haul the river rock from the Albany Quarry. They will use the river rock to help build the roadway up. Fletchall will contact Julie about it, and have her give a quote for the price to haul from that quarry. The commissioners also agreed that the entire length of CR 281/Lyon Ave south of Grant City should qualify for tax rock at a 100 T per mile haul rate.
- Commissioner Paxson reported that they found a holding tank for the dust suppressant. It will be installed at the county barn.
- Clerk Owens reported another complain on CR 206/120th road about the brush on the north end of it. That complaint was added to the others in the spreadsheet, and made the road eligible for a brush letter. Clerk Owens will send a brush letter to each landowner on the road. Even if they don't have brush as per the commissioners policy.
- Fletchall also reported another area that needs some work on brush, it is becoming a problem for equipment to get through. Clerk Owens will send a letter to this landowner on CR 169/188th Rd. as well.

Commissioner Nonneman made a motion to adjourn the meeting at 12:00. Commissioner Paxson seconded the motion. All in favor, motion carried.
